B Digitally processed data

Access rights to the data file on the World Village Festival website are limited within Fingo. Outside Fingo, only the person in charge of volunteers at World Village Festival has access rights to the data file.

10 Right of access

The data subjects (World Village Festival volunteer workers) have a right to access the recorded data on them. The request to access data stored in the personal data file must be directed to the contact person in matters related to the personal data file at the Fingo office. Personal Data Act, Section 24.

11 Right of rectification

Every data subject (World Village Festival volunteer workers) has the right to demand rectification of erroneous information in the data file. The request to rectify data stored in the personal data file must be directed to the contact person in matters related to the personal data file at the Fingo office.

12 Right of removal

Every data subject (World Village Festival volunteer workers) has the right to demand removal of the data on them recorded in the data file. In practice, this means the termination of the newsletter subscription, which may be done through the unsubscribe link found in the newsletter.

13 Storing of data

The data on every data subject (World Village Festival volunteer workers) will be stored at the most until the May of the following calendar year, at which point the previous year's volunteer data file is emptied.
